

Calico Rock School District Ready for Learning Plan 2023-2024 (updated August 2023)

The Calico Rock School District is steeped in rich tradition and history. The District serves the educational needs of those who live in the townships and surrounding communities of Calico Rock and is blessed with a strong sense of community. The district is willing to change the way the traditional curriculum is taught in order to better meet the educational needs of our student body with the ability to offer face to face on site instruction, online instruction. A combination of the two is available at the highschool.

Learning Platform

The Calico Rock School District faculty and staff will continue to strive to ensure students have the resources necessary to participate on-site or a digital learning experience. Our learning plan is designed to reinforce the fundamental curriculum of each course offered at Calico Rock and to introduce new learning material needed for each class.

For those students who choose virtual learning, the elementary school will be using a teacher on campus who will provide this option for K-6. The high school will offer a virtual option for students in grades 9-13 using Virtual Arkansas and grades 7-8 can use Arkansas River Educational Cooperative.

The school district will start with assessing each student to determine the unfinished learning from the prior school year. These assessments will be through the K-2 and 3-8 iReady assessments. The school will utilize the data collected in order to create an individualized learning plan for each student. Secondary grade levels will be assessed using Math IXL programs and IReady for Literacy. The district will continue to use the IReady Interim assessment tools, as well as classroom facilitator assessments.

Teachers will provide instruction through videos, live streaming software, and/or Google Classroom. Teachers and staff will be available to communicate with students and parents/guardians by phone, email, Zoom sessions or face to face meetings to provide additional support. Information and demonstration will also be offered for parents and students during open house on site or online for information regarding student curriculum needs. Continued communication with parents and students will be provided from the school district's website, mass text alerts and the social media pages of the school district. Information will also be sent to local media outlets as deemed necessary.

The Calico Rock School District will provide a device for all students unless the student prefers to use their own device.

Health and Wellness

The district will continue to meet the needs of our student's health and wellness by providing contact with our school counselor as well as using contracted mental health providers such as Families Inc. Counseling Services whether it be face to face interactions or by using some type of virtual meeting, such as google meet/zoom or some variation of both.

Teacher Training

High School

Teachers will receive training that the district deems as necessary as well as mandated professional development required by DESE. There will be additional training throughout the year as needed. The training can be online, face to face or a combination of the two.

Teachers will analyze student data and create personalized learning options for the students. The district will provide teachers training in house, outside sources, online or a combination of the above.

Opening the 2023-2024 School Year

The Calico Rock School Board of Education met in August 2023 and decided that the Calico Rock School District will continue to follow CDC guidelines with the expiration of the Arkansas mask mandate. The decision was made to stop using masks for the 23-24 school year and to allow visitors back on school grounds.

There will also be no masks required at school events this year.

Public Health Considerations

The K-6

Teachers:

Teachers are expected to upload all resources and materials at least one day prior to the virtual lessons. Teachers will teach daily virtual lessons for core instruction for students in the synchronous environment. virtual lessons will be recorded so students can revisit the lessons for a refresher, or if the student missed a virtual lesson.

Teachers will remind students to attend virtual lessons, pull small groups, and/or work 1:1. These requests will be based on student needs identified by robust grading practices. Teachers will be available for additional support during their office hours so that synchronous and asynchronous students (and their parents/caregivers) can communicate with the teachers as the need arises. Turnaround time for responses from teachers is a maximum of one business day. All teachers will have daily designated office time for support.

Students:

Regular attendance to the virtual lessons is crucial to the academic growth of the students; therefore, it is expected that students will attend and complete 64,220 minutes of instructional content. Days missed due to illness or other events will be made up through small group instruction, asynchronous lesson review, or other methods deemed to be in the best interest of the student. If additional time or support is needed, the student and/or caregiver should contact the teacher during his or her office hours

Asynchronous students are expected to follow the policy set by their districts regarding the standards for completion of work in a timely manner.

All students have a variety of options for connecting synchronously with our teachers--email, office hours, etc. Students also have their teachers' phone numbers.

Grades 7-8 Arkansas River Educational Cooperative

Grades 9-12: Virtual Arkansas is a "high touch" virtual learning experience that harnesses the benefit of synchronous or "live" instruction married with aligned asynchronous courses. This allows for students and instructors to develop relationships, address needed "just-in-time" instruction, and flexibility with learning. At the High School level, students are provided the opportunity to attend two Zoom sessions per week, per content area, and request additional one:one Zoom sessions as needed. While Zoom sessions are not required, they are highly encouraged as empirical data has shown students who attend Zoom are shown to be more successful than students who do not attend Zoom. Students/teachers are also able to communicate 24/7 via the CANVAS LMS messaging or the SIS email system that is monitored by Virtual Arkansas. Teachers are expected to reply to students within 24 hours of a student communication during the school week. Students are expected to read and interact with messages in their courses on a daily basis during the school week.

The program will provide instruction using a model that is primarily synchronous with an asynchronous option. Students will engage in digital coursework through Google Classroom. All students will have the opportunity to participate in virtual lessons sessions for synchronous learning with the teacher. Google Classroom uses a variety of methods of communication to do this and partners with schools to ensure students are cared for. When a situation arises where intervention is determined to be needed beyond what can be done virtually the district administration will be notified. Teachers are trained to report maltreatment/abuse to the Department of Health Services. Additionally, appropriate professional development such as G.U.I.D.E. for Life will be provided to teachers to support SEL strategies.</p> <p>Grades PreK-12</p> <p>Meals are provided for students who choose to participate in the district's child nutrition program. Calico Rock Public Schools has access to the Go Guardian in order to monitor students in real-time. Teachers will initiate intervention when it is determined a student isn't actively engaging or successfully mastering the content. Regular and frequent assessment will be utilized to identify struggling students. Students who demonstrate lack of achievement will participate in conversations with the building administrators to arrive at solutions to the lack of progress.

As part of our intervention process, we use IReady to assess learning gaps and utilize content resources that support individual learners on their levels.

Professional Development offered to virtual teachers is approved by the Arkansas Department of Education and counts towards the required 36 hours of Professional Development required for teachers each year. Additional continuous learning requirements for certification are generally met through graduate-level course work and/or additional external training opportunities.
